

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.amigosmexrestaurant.com and Amigos Mexican Restaurant and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Amigos Mexican Restaurant include www.amigosmexrestaurant.com and Amigos Mex. The Amigos Mex website is a restaurant site. By using the Amigos Mex website, you consent to the data practices described in this statement.

Collection of your Personal Information

Amigos Mex may collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Sharing Information with Third Parties

All such third parties are prohibited from using your personal information except to provide these services to Amigos Mex, and they are required to maintain the confidentiality of your information.

Amigos Mex may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Amigos Mex or the site; (b) protect and defend the rights or property of Amigos Mex; and/or (c) act under exigent circumstances to protect the personal safety of users of Amigos Mex, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Amigos Mex. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to

maintain quality of the service, and to provide general statistics regarding use of the Amigos Mex website.

- SSL Protocol

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
